Thank you for your information request which was received on 29 June 2020.

This is a response under the terms of the Freedom of Information Act ('the Act') only. Nothing in this response should be taken as meaning that any personal data is or is not held by HS2 Ltd.

REQUEST

I have reason to believe that you, or your contractors, obtained CCTV footage of me on Wednesday 24th June while I participated in the XR Rebel Trail walk between Waddesdon and Wendover. I request that you supply copies of this footage under the GDPR.

This image illustrates your team in action at 17:37, at Fairford Leys football pitches near Aylesbury (Lat 51:48:40, Long 0:50:20); I can be identified as the person taking this photograph with a phone. I also request any images captured earlier that day, while I was walking the Waddesdon Greenway near your work site at Fleet Marston.

In addition, I request (under the Freedom of Information Act) documents to show that this operation was conducted in accordance with the principles of the surveillance camera code of practice, as set out here

RESPONSE

Under the Freedom of Information Act 2000 ('the Act'), you have the right to:

HS2 Ltd does not own or operate any CCTV systems. As a result, we do not hold any information relevant to your request.

The organisations that HS2 Ltd have engaged to operate the sites of the HS2 project are required by us to maintain appropriate security for those sites and this may include CCTV systems. Those organisations (or the sub-contractors they have engaged to operate the CCTV specifically) are the controllers and owners of any data captured by those systems, and any request for copies of footage should be made directly to them.
